2. No image supplied may be further reproduced without a fresh request for use and (if agreed to) payment of the relevant charges.
3. The Society is to be clearly identified by its full name as (i) the source of the image **and** (ii) the copyright owner. If more than one image is used in the same publication, the abbreviation “NZRLS” may be added after the Society’s full name at the first illustration and subsequent illustrations may be acknowledged by the initials “NZRLS” only.
4. Under no circumstances will negatives or originals be supplied.
